**Legal Guidelines**

Anyone not complying with all of the contest rules will automatically be disqualified. No telephone calls or correspondence will be accepted inquiring on judges' selections. By entering, the individual student entrant and his/her parent or legal guardian, or the school/district entrant and all those involved in compiling entry materials grant the Sponsor (GLSEN) the right to copy, edit, publish, promote, broadcast or otherwise use, in whole or in part, their entries in any manner without further permission, notice or compensation.

In the event that there are an insufficient number of entries received that meet the minimum standards for any of the three entry categories (as determined by the judges), all prizes may not be awarded. By accepting a prize, each individual student winner and his/her parent or legal guardian, and each school/district entrant and all those involved in compilation of entry materials grant the Sponsor the right to use his/her individual or school/district name and likeness for any advertising, promotion, trade or any other purpose without further compensation or permission, except where prohibited by law.
